Independent Auditor's Review Report on quarterly Unaudited Financial Results of GKW Limited pursuant to the Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended)

To the Board of Directors **GKW** limited

- 1. We have reviewed the accompanying Statement of Unaudited Financial Results of GKW Limited ("the Company") for the quarter ended June 30, 2024("the Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulation').
- 2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder (hereinafter referred to as "the said Indian Accounting Standard") and other accounting principles generally accepted in India. Our responsibility is to issue a report on the Statement based on our review.
- 3. 

1. The above unaudited results have been reviewed by the Audit Committee and subsequently approved by the Board of Directors of the Company at their respective meetings held on August 13, 2024. The Statutory Auditors of the Company have reviewed the results for the quarter ended June 30, 2024.

2. Revenue from Operations includes:

Gain on fair valuation of Current Investments amounting to Rs.472.13 Lakhs for the quarter ended June 30, 2024, Rs 303.33 Lakhs for the preceding quarter ended March 31, 2024, Rs 420.53 for the quarter ended June 30, 2023 and Rs 1514.56 Lakhs for the year ended March 31, 2024.

3. Other Expenses includes:

Rs 356.71 Lakhs paid during the quarter ended June 30, 2024, Rs 178.94 lakhs paid during the quarter ended June 30, 2023 towards resolution of certain disputes and Rs 589.81 Lakhs paid during the preceding quarter ended March 31, 2024, Rs 793.75 lakhs paid during the year ended March 31, 2024 being amount paid (including consultancy charges) for obtaining confirmation in order to avoid future litigation/disputes towards certain parcels of land of the Company and resolution of certain disputes.

- 4. The figures for the quarter ended March 31, 2024 are the balancing figures between audited figures in respect of the full financial year and published year-to-date figures upto the end of the third quarter of the respective financial year.
- 5. Previous year/periods' figures have been rearranged/regrouped, wherever necessary, to make them comparable with those of the current
